#### Good Morning,

#### Absolutely!

At the site, there are 3 existing signs in place, that have been there for years. A small wall plaque next to the front door, a larger wall sign for visibility on the side elevation and a v-shaped ground sign on the corner. Our plan is to remove all of the signage and update it – similar to a refurbish, but with all new signage. Below is a breakdown of detail, by sign.

- Small Wall Plaque
  - o Existing material consists of ¼" plate aluminum letters mounted flush to a 1" thick aluminum pan.
  - New proposed signage will consist of the same material and design as the existing.
  - See Page 4 of the attached drawings
- Illuminated Wall Sign
  - o Existing material consists of a non-illuminated aluminum pan sign with vinyl graphics
  - New proposed signage will consist of a single-sided internally illuminated aluminum pan sign with routed acrylic copy and 1<sup>st</sup> surface translucent vinyl applied to the letters.
     Design will look exactly the same as the existing.
  - See Page 3 of the attached drawings
- V-Shaped Ground Sign
  - o Existing material consists of posts and panel type signage with vinyl graphics
  - New proposed signage will consist of a v-shaped internally illuminated monument sign, set in concrete footings. Graphic copy will be push-through acrylic in the faces of the cabinet.
  - See Page 1-2 of the attached drawings
