Design Exceptions

The purpose of a design exception is to allow a developer to seek variance from Sections 7.2.4.D.2, 7.2.4.D.3, or 7.2.8.B of the Unified Development Ordinance (UDO) and/or Stormwater Management policies found outside the UDO.

Prerequisites

A request for design exception may be submitted at the time of application for a preliminary subdivision plan, site plan, or similar permit. A design exception may also be requested by staff during plan review if it is deemed necessary. The application cannot be processed until a plan is in review. The design exception must be approved prior to any plan approval.

Submittal Requirements

- Stormwater Design Exception Application (this must be filled out in its entirety as failure to do so will result in delay of processing)
- The application must be notarized
- Applications may be submitted via email (see contacts on sidebar for email addresses) or hardcopy
- A vicinity map clearly identifying the property
- Applicable plot plan showing:
 - Proposed improvements labeled with all necessary material types/sizes
 - o Existing pipes, drainage structures, swales, and easements
- Profile view of the improvement encroachment into easement
- The code/design manual or policy section that an exception is being requested for
- Narrative justification of proposed work and how it will not negatively affect the intent of drainage easement
