## Triangle Chiefs Speak on WSHA

On October 9, Chief Deck-Brown was joined by Morrisville Police Chief Patrice Andrews and Durham Police Chief C.J. Davis on the monthly Behind the Badge with Chief Cassandra Deck-Brown radio program on Shaw University's WSHA (88.9 FM). The chiefs shared their individual experiences and journeys, and activities in their departments. Each chief also encouraged listeners to join the law enforcement field.

Not only in North Carolina, but all over the country, females are taking the leadership role at police departments of all sizes. This is a testament to their education, experience, tenacity, stamina, compassion, and unique problem-solving skills.

In September, WRAL's [On the Record](#) highlighted four of the six female, African-American police chiefs in North Carolina: Raleigh's Chief Cassandra Deck-Brown; Morrisville's Chief Patrice Andrews; Durham's Chief C.J.

Davis; and Fayetteville's Gina Hawkins. Chief Catrina A. Thompson leads Winston-Salem's police department and Chief Bernette Morris serves in Morehead City. Later in the month, the four chiefs were also featured on NBC's [Megan Kelly TODAY](#) and \$20,000 in scholarship funds was donated in their names to N.C. Women in Law.

## Retirements

### Lieutenant K.D. Huff Retires



On September 21, Chief Deck-Brown presented Lieutenant K.D. Huff with a Chief's Citation for his service to the Department. Lieutenant Huff began his career with the Department as a member of the 58th Academy. He served as a patrol officer on B Platoon and was promoted to Detective in 1998, serving with the Drugs and Vice Unit, the Drug Enforcement Task Force, and the Northeast Detective Squad. In 2005, he was promoted to Sergeant, supervising patrol officers in the Southwest District. Huff returned to the Detective Division in 2006 where he supervised the Commercial and North Burglary units, the Special Victims Unit and the Homicide Unit. During this time, he and his squads received two Meritorious Unit Citations: one for capturing a serial rapist; the second for the capture of a serial robber and predator who preyed upon the elderly. In April 2013, he was promoted to Lieutenant in the Southeast District. In 2015, he was assigned to the Youth and Family Services Unit in the Detective Division. His love for

baseball and working with youth led to a partnership with MLB Reviving Baseball in the Inner Cities (RBI) and expanded the Department's youth baseball program. In 2017, Lieutenant Huff was assigned to the North District Patrol Division where he remained until his retirement on October 1.

### Lieutenant M.L. Peterson Retires

On October 29, Chief Deck-Brown presented Lieutenant M.L. Peterson with a Chief's Citation for his service to the Department. Lieutenant Peterson began his career with the Department as a member of the 57th Academy. He served as a patrol officer, was certified as a Drug Recognition Expert, a Field Training Officer, and a Major Accident Investigator. Lieutenant Peterson served as a Traffic Enforcement Officer early in his career and was dedicated to making the roadways safer for everyone. Lieutenant Peterson was promoted to Sergeant and supervised patrol officers in the Northeast District and the Community Policing Squad. He led the South General, the Aggravated Assault, and the Homicide units in the Detective Division. He also served with the Robbery Task Force and the Raleigh Intelligence Center. In 2016, he was promoted to Lieutenant and assigned to the Southwest District where he served until his retirement on October 1.
