I. Introduction

Mr. Nevill called the meeting to order at 6:02 pm and asked everyone to introduce themselves.

II. Approval of Minutes

Mr. Nevill requested that “New Leesville Road” be corrected to “New Leesville Boulevard” in the February 23, 2018 minutes. Ms. Hatchell moved for approval of the minutes which was properly seconded by Mr. Howe and was approved by unanimous voice vote.

III. Public Comments

Molly McKinley of Oaks & Spokes requested that the commission continue pursuing a dockless bikeshare permitting program. Ms. McKinley suggested incentivizing biking and walking to attend City Council,



boards, and commissions meetings in addition to the free parking vouchers that the City is now providing for meeting attendees.

IV. Staff Reports

Staff Updates

Mr. Lamb introduced the new City of Raleigh Transportation Director, Michael Moore, and newest Transportation Planner, Tara Hofferth. Mr. Lamb also discussed the recent spam that was sent to BPAC commissioners.

City Project Updates

City staff have submitted to NCDOT the environmental document that will authorize funding for the purchase and installation of bikeshare station equipment. The City is still anticipating a July launch date and has initiated outreach and promotion.

City Council Updates

Mr. Lamb stated that City Council affirmed all but two of the streets BPAC recommended for bike lanes in conjunction with the City's annual street resurfacing. City Council did not approve parking restrictions on Glen Eden Drive (between Ridge Road and Glenwood Avenue) or Spruce Tree Way. The marking plans will be finalized and resurfacing will take place from April to October.

V. Committee & Member Reports

Chair's Report

Mr. Nevill mentioned that events described in the online version of the agenda are linked to the event they describe. It was confirmed that City Councilmember David Cox is now the BPAC liaison. Mr. Humphrey and Mr. Nevill are up for reappointment as BPAC members. The Raleigh Neighborhood College will be holding a class on transportation issues and Mr. Nevill will be presenting on issues relevant to BPAC the week of February 26.

Bicycle Planning Committee

Mr. Humphrey reported that the committee discussed the implementation of the BikeRaleigh Plan and how it addressed dockless bikeshare, e-bikes, and wayfinding signage.



Community Outreach Committee

Ms. Proudfoot reported that the committee discussed meeting with public officials, public education for bikeshare, attendance at CAC meetings, community outreach in anticipation of Bike Month, and changing their meeting date. The April committee meeting date will not be affected.

Pedestrian Planning Committee

Ms. Hatchell reported that the committee discussed their work plan, the effect of construction zones on pedestrians, and crash data. Ms. Hatchell requested staff present information on Vision Zero at the April meeting. Mr. Lamb suggested the Vision Zero initiative be included in their draft work plan as it is a major policy change and would require City Council approval. The committee also suggested that the commission get involved with shops that host bike maintenance workshops during Bike Month.

VII. New Business

Greenway Wayfinding, Kris Morley-Nikfar, City of Raleigh PRCR

Mr. Howe and Ms. Hatchell discussed options to incorporate wayfinding and greenways for both recreational and commuting use throughout the city.

Cross-Town Neighborhood Bikeway, Trung Vo, City of Raleigh Transportation

Mr. Vo presented on traffic calming, pavement marking, and intersection treatment options supplied by NACTO. There are currently 13 neighborhood bikeway priority projects in the 2016 BikeRaleigh Plan. Commissioners discussed implementing wayfinding as a comprehensive system instead of through individual projects. Mr. Lamb stated this project this would primarily be a marking and branding effort. The commission discussed greenway connectivity as construction on Capital Boulevard proceeds.

Raleigh Bike Month, Trung Vo, City of Raleigh Transportation

Mr. Vo presented a calendar of events and requested volunteer help from the commissioners.

VIII. Board Comments

Mr. Otwell and Ms. Stuart proposed disbanding the Open Streets Ad-Hoc Committee and recruiting outside assistance for planning an Open Streets event. Mr. Otwell advised he would utilize resources

suggested by Mr. Howe to obtain an estimate for a consultant. Ms. Stuart moved that the Open Streets Ad-Hoc Committee be terminated. Mr. Otwell seconded and the motion was passed by unanimous voice approval.

Mr. Otwell stated that the Pedestrian Planning Committee is considering asking City Council for funding for the purchase of bicycle/pedestrian volume data collection equipment. Mr. Vo stated that the Bicycle and Pedestrian Program is already investigating the creation of a continuous count program for this year.

Mr. Vo provided a recap on the Triangle Bicycle & Pedestrian Workshop. Ms. Burruss will present on dockless bikeshare regulation strategies at the next BPAC meeting.

The committee reviewed the BPAC FY18 Work Plan discussed drafting the Pedestrian Planning Committee initiatives for the BPAC FY19 Work Plan. Potential work plan items could include investigating best practices for pedestrian accommodations through work zones. Ms. Sell cited major concerns regarding the Capital Boulevard/Peace Street interchange reconstruction.

The committee also discussed evaluating high bicycle/pedestrian crash locations and identifying the intersections that are not slated to be improved through planned and funded projects. Commissioners developed a rough framework for data and analysis of each intersection to be improved for pedestrian safety. Discussion included the exploration of a Vision Zero program within the City of Raleigh.
