Visit the National Railroad Museum & Hall of Fame which houses priceless artifacts from the former Seaboard Airline Railroad era. The group will have a delicious buffet lunch at Seaboard Station Restaurant. Explore the history of the Hamlet Depot & Museums, located in the only Victorian Queen Anne train station in North Carolina which still serves as an active Amtrak station. Take a walk along the Seaboard Trail to visit 18 historic sites and buildings. The group will arrive back at the Anne Gordon Center in Raleigh at approximately 5:30pm.
