## NC Mountains

October 12-14, 2015

**Have you always wanted to visit the Smoky Mountains in the fall to enjoy the color-filled sights?** Here is your chance to see the Blue Ridge Parkway in the fall. We will be leaving from the Anne Gordon Active Adult Center at Millbrook Exchange Park (1901 Spring Forest Road) at 8:00a.m.

Our three-day two-night trip to the NC mountains will begin with a drive along the Blue Ridge Parkway. Sit back and enjoy a scenic tour with photo stops along the way. The group will check into the Doubletree by the Hilton Asheville-Biltmore Village which will be our home for the next two nights. Enjoy dinner on your own at T.G.I. Fridays located within the hotel.

Begin your day with a cooked-to-order breakfast at the hotel. We will head out to Bryson City, NC where we will board the Great Smoky Mountains Scenic Railway for an excursion along the Tuckasegee River. We will travel in a mid-1920's restored Crown Class Car equipped with large picture windows for optimal viewing. A private car attendant will be present and a box lunch will be provided. This round trip ride will allow you time to visit the many unique shops or explore the historic town of Dillsboro, NC. The group will then return to Asheville where you will have time on your own to explore and eat dinner.

Pack your bags and enjoy another wonderful breakfast before we depart for Lake Lure, NC. Upon arriving at the 720 acre lake, made up of crystal clear blue water, we will board a chartered tour boat. Relax as you visit the locations used in the movie Dirty Dancing, hear about the legends, and learn of the cultural history of the area. Next we will enjoy a full buffet lunch at the 1927 Historic Inn followed by a guided tour of the Inn. The group will arrive back at the Anne Gordon Center in Raleigh at approximately 8:00p.m. with a dinner stop en route.
